The Project Director for the National LAP Technical Assistance and Phase II of the Domestic Violence Homicide Prevention Demonstration Initiative will oversee the national LAP-related projects. The primary responsibility of this position is project and personnel management.

Duties and Responsibilities:

Project Management

- Provide overall management and oversight of the national LAP projects, including the national LAP training and technical assistance project and the national domestic violence homicide prevention demonstration initiative.
- Ensure compliance with OVW cooperative agreements.
- Serve as a point of contact for OVW and other partners.
- Participate in the coordination and facilitation of meetings and teleconferences.
- Problem-solve any logistical, relational, political, or technological issues throughout all phases of the projects.
- Assist in development and oversight of project budget.
- Prepare and submit OVW record-keeping documents, including semi-annual reports, GANs, etc.

Supervision

- Supervise project staff, from point-of-hire to training, coaching, and professional development.
- Manage relationships and supervise consultants on LAP-TA and DVHP awards.

Training and TA

- Oversee national LAP training and implementation.

- Serve as a content expert on the Lethality Assessment Program (LAP).
- Lead and facilitate the LAP Advisory Council and facilitate or supervise Advisory Council subcommittees.
- Provide training and technical assistance on the LAP, as needed.
- Develop training curricula, technical assistance documents, and other products, as needed.
- Provide program evaluation and data analysis.
- Research and maintain a working knowledge of emerging issues and trends pertaining to domestic violence, especially to intimate partner violence and homicide prevention.

Communications

- Point of Contact for all media inquiries regarding national LAP.
- Point of Contact/Lead partnership with all national partners, including other national TA providers, regarding LAP.
- Lead or supervise external national LAP communications, including LAP Links, the LAP website, etc.
- Attending and providing project-related updates in staff meetings.

MNADV General

- Providing support for agency-wide events, such as MNADV's Annual Memorial Service, Annual Meeting, and statewide conferences.
- Representing MNADV at meetings, committees, and events related to the project.
- Coordinating with staff, board members, and partners on project-related and agency-wide activities.
- Attending staff meetings, weekly training team meetings, and ad hoc meetings.
- Respond to crisis calls and information/referral requests from domestic violence survivors, concerned individuals, service providers and allied professionals.
- Respond to, manage, and refer telephone, e-mail, and in-person inquiries from professionals and the public about domestic violence.

Minimum Qualifications:

- Strong organizational and program management skills required.
- Strong computer skills required.
- Strong verbal and written communication and interpersonal skills required. Must be able to work with a broad diversity of professionals and have a professional demeanor.
- Must be responsible, reliable, professional, and punctual.
- Must be able to travel to meetings, trainings, and events in DC/Maryland area, with national travel required.
- Minimum of a bachelor's degree required or commensurate professional experience; Master's degree preferred.

- Expertise or demonstrated commitment to learning about domestic violence, with a preferred minimum of one year of experience in the field of domestic violence, sexual assault, stalking or women's issues.
- Working knowledge of the Lethality Assessment Program-Maryland Model (LAP) and/or Domestic Violence High Risk Team Model preferred.

Benefits:

- Position is on-site, 40 hours per week.
- Health benefits available.
- Paid holidays. Paid leave is accrued (sick and vacation).
- Mileage reimbursement for statewide and national travel.
